PURPOSE: Discussion Item

Purpose of Submittal:

At its last meeting, the Board adopted a revised statement of mission and strategic direction for Western. During the Thursday afternoon session, the vice presidents will report on how that direction is now being used to direct planning and budgeting at the tactical level.

This will include "hands on" exploration of current KPI's using laptops that will be available to each Trustee for use during that portion of the meeting.
